

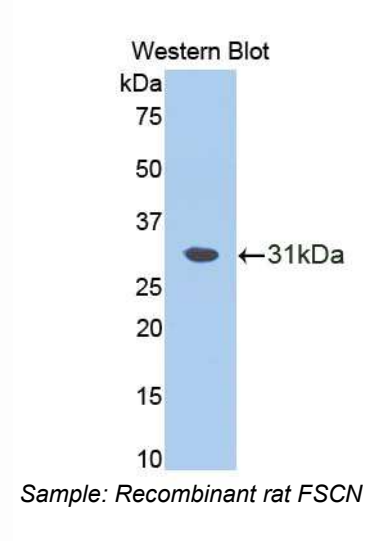

### **[ ANTIBODY SPECIFICITY ]**

Anti FSCN is a rabbit polyclonal antibody raised against rat FSCN. This antibody has been selected for its ability to recognize rat FSCN in immunohistochemical staining and western blotting, non cross-reactive with other members of the family.

### **[ APPLICATIONS ]**

Western blotting: 1:100-400

Immunocytochemistry in formalin fixed cells: 1:100-500

Immunohistochemistry in formalin fixed frozen section: 1:100-500

Immunohistochemistry in paraffin section: 1:50-200

Optimal working dilutions must be determined by end user.

### **[ CONTENTS ]**

**Form & Buffer:** Supplied as solution form in PBS, pH 7.4, containing 0.02%Na<sub>3</sub>N, 50% glycerol.

### **[ QUALITY CONTROL ]**

**Content:** The quality control contains recombinant rat FSCN (Glu8~Cys260) disposed in loading buffer.

**Usage:** 10uL per well when 3,3'-Diaminobenzidine(DAB) as the substrate.  
5uL per well when used in enhanced chemiluminescent (ECL).

Note: The quality control is specifically manufactured as the positive control. Not used for other purposes.

**Loading buffer:** 100mM Tris(PH 8.8), 2%SDS, 200mM NaCl, 50% glycerol, BPB 0.01%, Na<sub>3</sub>N 0.02%.

### **[ STORAGE ]**

Store at 4°C for frequent use. Stored at -20°C to -80°C in a manual defrost freezer for one year without detectable loss of activity. Avoid repeated freeze-thaw cycles.
