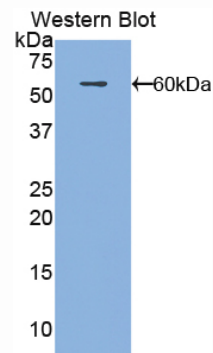

## **[ ANTIBODY SPECIFICITY ]**

The antibody is a rabbit polyclonal antibody raised against FSIP1. It has been selected for its ability to recognize FSIP1 in immunohistochemical staining and western blotting.

## **[ APPLICATIONS ]**

Western blotting: 1:100-400

Immunocytochemistry in formalin fixed cells: 1:100-500

Immunohistochemistry in formalin fixed frozen section: 1:100-500

Immunohistochemistry in paraffin section: 1:50-200

Enzyme-linked Immunosorbent Assay: 1:100-200

Optimal working dilutions must be determined by end user.

## **[ CONTENTS ]**

**Form & Buffer:** Supplied as solution form in PBS, pH7.4, containing 0.02% NaN<sub>3</sub>, 50% glycerol.

## **[ QUALITY CONTROL ]**

**Content:** The quality control contains recombinant FSIP1 (Asp55~Asp287) disposed in loading buffer.

**Usage:** 10uL per well when 3,3'-Diaminobenzidine(DAB) as the substrate.  
5uL per well when used in enhanced chemiluminescent (ECL).

**Note:** The quality control is specifically manufactured as the positive control. Not used for other purposes.

**Loading Buffer:** 100mM Tris(pH8.8), 2% SDS, 200mM NaCl, 50% glycerol, BPB 0.01%, NaN<sub>3</sub> 0.02%.

## **[ STORAGE ]**

Store at 4°C for frequent use. Stored at -20°C to -80°C in a manual defrost freezer for one year without detectable loss of activity. Avoid repeated freeze-thaw cycles.
