

[ANTIBODY SPECIFITY]

The antibody is a rabbit polyclonal antibody raised against BGN. It has been selected for its ability to recognize BGN in immunohistochemical staining and western blotting.

[APPLICATIONS]

Form & Buffer: Supplied as solution form in PBS, pH7.4, containing 0.02% NaN₃, 50% glycerol.

[QUALITY CONTROL]

Content: The quality control contains recombinant BGN (Leu53~Arg166) disposed in loading buffer.

Usage: 10uL per well when 3,3'-Diaminobenzidine(DAB) as the substrate.

5uL per well when used in enhanced chemilumescent (ECL). **Note:** The quality control is specifically manufactured as the positive control. Not used for other purposes.

Loading Buffer: 100mM Tris(pH8.8), 2% SDS, 200mM NaCl, 50% glycerol, BPB 0.01%, NaN $_3$ 0.02%.

[<u>STORAGE</u>]

Store at 4°C for frequent use. Stored at -20°C to -80°C in a manual defrost freezer for one year without detectable loss of activity. Avoid repeated freeze-thaw cycles.
